185. <u>Question:</u> Reference drawings 840-S-14, 840-S-42, & 840-S-45 : # 9s @ 6" o.c.e.w.t.&b. are indicated in section A / 840-S-42. # 7s @ 6" o.c.e.w. on top and # 7s @ 6" o.c. in one direction on the bottom and 12" o.c. in the other direction on the bottom are indicated in sections F & G / 840-S-45. Which one is correct ? What is the correct reinforcing to use for the base mat foundation detailed on these three referenced drawings?

<u>Answer:</u> For the base slab in the effluent and outfall area the reinforcing should be as follows: #7@6" Top Each Way; For the "short" direct reinforcing on the bottom should be #9@12" ALT W/#10@12"; Reinforcing in the "long" direction on the bottom should be #9@6". Refer to updated drawings attached.

186. <u>Question:</u> Reference drawings 840-S-14, 840-S-42, & 840-S-45 : The plan view on drawing 840-S-14 shows the new walls and mat foundation starting at the same point, approximately 80-feet from the north end of the structure. However, the section view on drawing 840-S-42 shows the new mat foundation ending just south of the second new interior wall, approximately 43-feet from the north end of the structure. Please confirm that the new mat foundation for the new north extension of the BCCT starts as the same location as the new walls, as indicated on the plan view.

Answer: Section is correct as indicated on 840-S-42. Refer to updated drawing.
