

OFFICIAL RULES Follow The Flush Giveaway

July 19 through July 30, 2021, Allegheny County Sanitary Authority (“ALCOSAN”) will be conducting a giveaway entitled “Follow The Flush” Giveaway” via its microsite, alcosan.org. The giveaway will last 11 days, and one winner will be awarded a \$75 Uber Eats gift card on Monday, July 26, 2021 and another winner will be awarded a \$75 Uber Eats gift card on Monday, August 2, 2021. See official rules for details.

OFFICIAL RULES – NO PURCHASE IS NECESSARY TO ENTER.

SPONSOR: The Follow The Flush Giveaway is sponsored by ALCOSAN located at 3300 Preble Avenue, Pittsburgh, PA 15233.

ELIGIBILITY: The giveaway is open to legal residents of the 50 United States and the District of Columbia, who are age 18 or older at the time of entry. Void where prohibited by law. Employees of ALCOSAN, 9 Rooftops (“Administrator”), the immediate families of such employees (employees’ parents, siblings, children and spouses), members of the same household of such employees, and anyone involved in the production, development or handling of this Giveaway are not eligible. All federal, state, and local laws and regulations apply.

HOW TO ENTER: Beginning Monday, July 19, 2021 at 12:00:01 AM EDT, entrants can visit the Follow the Flush page on www.alcosan.org and enter their contact information to enter the giveaway. The giveaway will end on Friday, July 30, 2021 at 11:59:59 AM EDT.

One winner will be chosen on Monday, July 26, 2021 at noon (12:00:00pm EDT) via a random number generator. Notification to the winner will be via the email address entered during the giveaway entry process and will also be posted on ALCOSAN’s social platforms. The winner of the giveaway will have seven days to respond. If the winner does not respond by 2:00 PM EDT of the seventh day after notification, a new winner will be chosen using the same random number generator process. Any subsequent winners of the giveaway will also have seven days in which to respond. All winner decisions are final.

The second winner will be chosen on Monday, August 2, 2021 at noon (12:00:00pm EDT) via a random number generator. Notification to the winner will be via the email address entered during the giveaway entry process and will also be posted on ALCOSAN’s social platforms. The winner of the giveaway will have seven days to respond. If the winner does not respond by 2:00 PM EDT of the seventh day after notification, a new winner will be chosen using the same random number generator process. Any subsequent winners of the giveaway will also have seven days in which to respond. All winner decisions are final.

Multiple registrations from the same entrant may result in ineligibility to receive a prize. Administrator’s computer is the official time-keeping device for the Giveaway.
